SECTION 4: FIRST AID MEASURES

4.1 Description of first aid measures

General notes

Never give anything by mouth to an unconscious person. Place patient in recovery position and ensure airway patency. When in doubt or if feeling unwell seek medical assistance. Show the safety data sheet and label to the physician. No action shall be taken involving any personal risk or without suitable training. Following skin contact

Take off all contaminated clothing. Areas of the body that have come into contact with the product must be rinsed with water. Consult a physician.

Immediately flush eyes with running water, keeping eyelids apart. Seek medical help.

Following ingestion

Do not induce vomiting! Aspiration hazard if swallowed. Can enter lungs and cause damage. 4.2 Most important symptoms and effects, both acute and delayed

Following inhalation

Excessive exposure to spray mist, fog, or vapours may cause respiratory irritation.
